## Blackbushe Airport Crew Car Agreement

## **TERMS & CONDITIONS FOR USE**

This vehicle is provided for short journey use in and around the area local to Blackbushe Airport (10 mile radius). It is available on a complimentary basis to any crew of executive aircraft with a MTOW > 3,500kg. Please drive with consideration for other road users and remember the vehicle carries Blackbushe Airport logos, so any poor behaviour reflects badly on the airport. Please observe the following rules:

- 1. The vehicle must only be driven by the persons listed above, and only with the permission of Blackbushe Airport Ltd.
- 2. No person under the age of 25 may drive the vehicle.
- 3. The vehicle must not be driven by any person under the influence of alcohol, illegal substances, or prescribed medication.
- 4. All drivers must be licensed to drive a vehicle with manual transmission.
- 5. All drivers must provide a copy of their valid driving licence, and warrant that such licenses are valid and have no penalty points or other endorsements.
- 6. The vehicle requires <u>Diesel fuel</u>. The vehicle is usually supplied with a full tank of Diesel, and must be returned as such. A charge of £2.20 per litre of fuel will be made if the vehicle is returned with less fuel than at check-out.
- 7. The vehicle must be returned at the pre-agreed return time. If, for any reason the drivers need to return the vehicle later, they must contact Blackbushe Airport first for permission.
- 8. In the event of an incident or accident, the vehicle excess of £500.00 will be payable to Blackbushe Airport.
- 9. The drivers are liable for any speeding fines, parking tickets, congestion charges, or road tolls incurred during their usage. Blackbushe Airport will add a charge of £50.00 to deal with the administration of any unpaid fees or charges.
- 10. Blackbushe Airport is not liable for any claim raised against the driver as a result of the Driver or their passenger's actions or negligence whilst using the vehicle.
- 11. Blackbushe Airport is not liable for any cost or delay incurred by the Drivers as a result of the breakdown or other unserviceability of the vehicle, however caused.
- 12. Drivers must not authorise anyone to conduct any mechanical, repair, or recovery work on the vehicle without first receiving permission from Blackbushe Airport Ltd.

## Statement of Liability:

I acknowledge that for the period of the rental I shall be liable as the owner of the vehicle for any fixed penalty offence committed with respect to the vehicle or any penalty charge notice, any excess charge, or penalty charge for parking or bus lane contraventions which may be incurred and any charges and penalty charges incurred under a road user charging scheme.
